Opinion

The independent auditors' reports on financial statements/ Financial Results/financial information of these entities have been furnished to us and our opinion on the consolidated Financial Results, in so far as it relates to the amounts and disclosures included in respect of these entities, is based solely on the report of such auditors and the procedures performed by us are as stated in paragraph above.

The consolidated Financial Results include the unaudited Financial Results of one subsidiary whose Financial Statements/Financial Results/ financial information reflect Group's share of total assets of Rs.0.82 Cr. as at 31st March 2021, Group's share of total revenue of NIL, and NIL and Group's share of total net profit after tax of NIL and NIL for the quarter ended 31st March 2021 and for the period from 01st April 2020 to 31st March 2021 respectively, as considered in the consolidated Financial Results. These unaudited Financial Statements/Financial Results/ financial information have been furnished to us by the Board of Directors and our opinion on the consolidated Financial Results, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries is based solely


